DISTRIBUTION OF GAS ORDINANCE, 2016

DISTRIBUTION OF GAS (LICENSING) (AMENDMENT) REGULATIONS, 2020

(Made under section 32)

In exercise of the powers conferred by section 32 of the Distribution of Gas Ordinance [*Cap. 72*], the Minister, with the approval of the Majlis Mesyuarat Kerajaan Negeri, has made following Regulations:

Citation and Commencement

1. These Regulations may be cited as the **Distribution of Gas (Licensing) (Amendment) Regulations, 2020**, and shall be deemed to have come into force on the 12th day of December, 2019.

Amendment to the Principal Regulations

2. The Distribution of Gas (Licensing) Regulations, 2018 [*Swk. L.N. 146/2018*] (“Principal Regulations”) is amended by substituting the Schedule with the following new schedule.
