DISTRIBUTION OF GAS (LICENSING) REGULATIONS, 2018

DISTRIBUTION OF GAS (LICENCE FEES) NOTIFICATION, 2020

(Made under regulation 5)

In exercise of the powers conferred by regulation 5 of the Distribution of Gas (Licensing) Regulations, 2018 *[Swk. L.N. 146/2018]*, the Majlis Mesyuarat Kerajaan Negeri has approved the licence fees for distribution of gas, and the following Notification has been made:

Citation and Commencement

1. This Notification may be cited as the **Distribution of Gas (Licence Fees) Notification, 2020**, and shall be deemed to have come into force on the 12th day of December, 2019.

Licence fees

2. The licence fees for distribution of gas are as specified in the Schedule.

LICENCE FEES FOR DISTRIBUTION OF GAS

(*a*) Licence issued pursuant to section 7(*a*), (*b*), (*c*), (*d*) and (*g*) of the Distribution of Gas Ordinance, 2016 [*Cap.* 72]:

7(a)	Import of any gas for regasification, processing, treatment, separation, utilization or distribution in Sarawak	RM 0.001 per mmBTU
7(<i>b</i>)	Regasification of gas	RM0.005 per mmBTU
7(c)	Treatment, separation or processing of gas	RM0.001 per mmBTU
7(<i>d</i>)	Transportation of gas	RM0.005 per mmBTU
7(g)	Retail of gas	RM25 per year

* MMBTU = Million British Thermal Unit

(b) Licence issued pursuant to section 7(e) of the Distribution of Gas Ordinance, 2016 [*Cap.* 72] to build, manage or maintain gas pipeline or other apparatus or equipment or mechanism for the distribution of gas:
